Havilah Resources

Havilah Resources NL aims to become a significant producer of copper, gold, cobalt and molybdenum from its 100% owned Kalkaroo, Mutooroo and Benagerie projects, which are at advanced feasibility stage. It holds more than 6,500 km² of surrounding tenements in the highly mineralized Curnamona Province of South Australia, where it maintains an active drilling program. Deposits of iron ore, tin and hard rock uranium have been drilled, with good exploration upside. Havilah owns strategic interests in uranium explorer, Curnamona Energy (45.4%) and hot rock geothermal explorer, Geothermal Resources (58%).

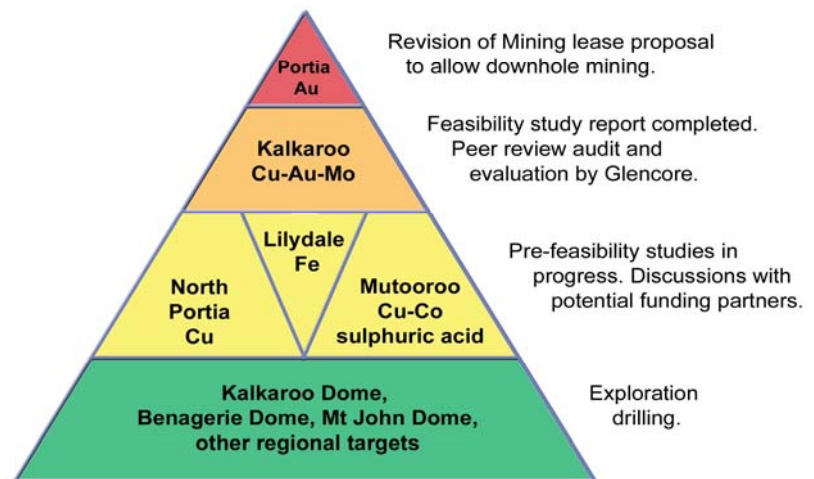

- Positive results being reported by several other junior explorers in the region, highlighting the potential of the Braemar Iron Formation as a significant regional iron ore target.

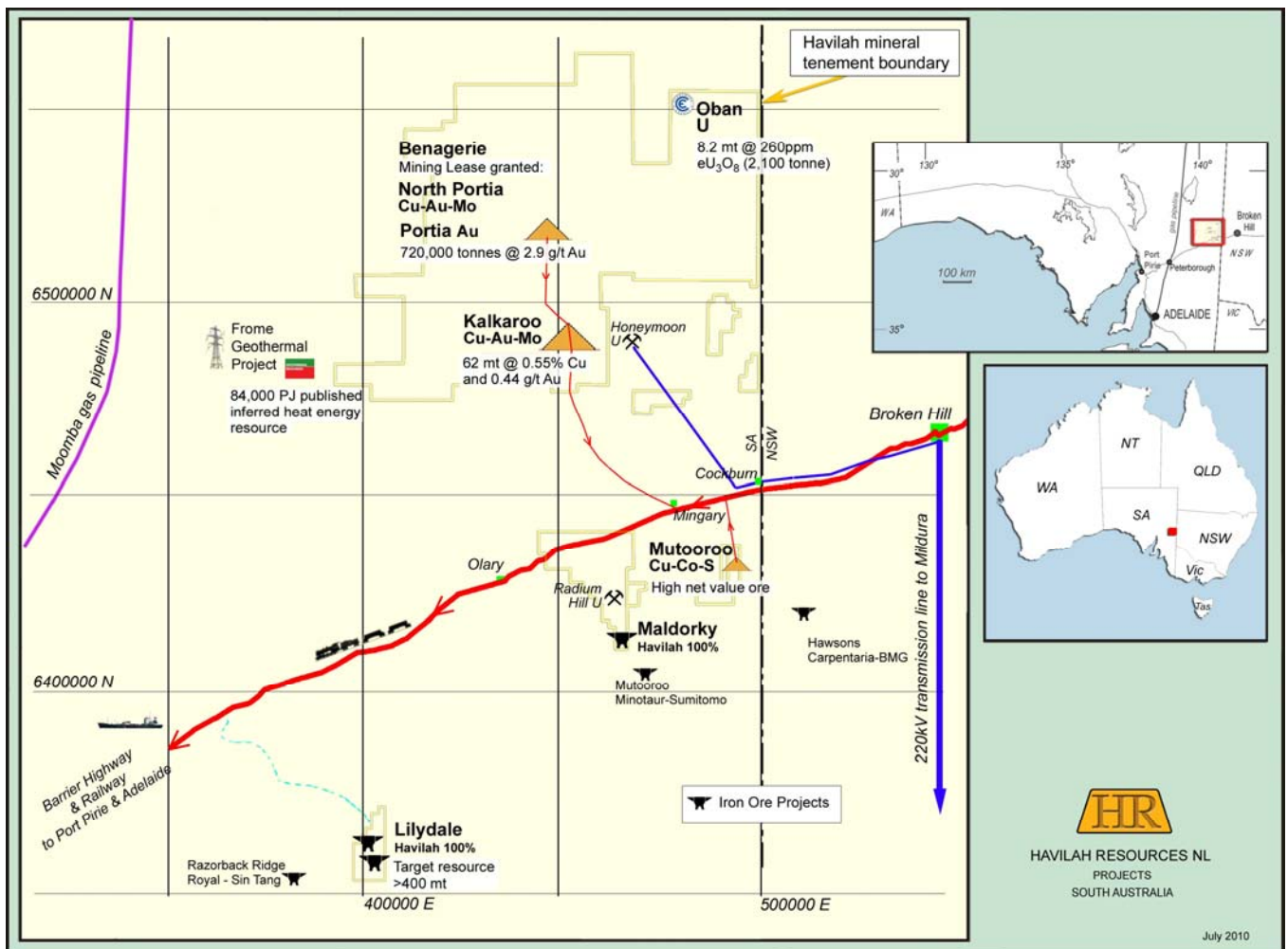
Havilah Project Status





Iron Ore Exploration

Havilah has previously published encouraging metallurgical results for its 100% owned Lilydale iron ore project southeast of Yunta, that show the primary low grade iron ore can be beneficiated into a high iron, low impurity magnetite product. Similar results have now been reported by several junior companies, exploring in joint venture on various Braemar Iron Formation iron ore projects in northeastern South Australia. The various projects lie south of the main Barrier Highway as shown on the accompanying map. This is indicating an emerging potentially important new iron ore province that has appreciable resource potential in addition to favourable metallurgical characteristics for upgrading to a premium product, and proximity to rail and port facilities.



Havilah has a second 100% owned iron ore project in the region, namely Maldorky. It lies along strike from the Mutooroo iron ore project of the Minotaur-Sumitomo joint venture, where very encouraging drilling and metallurgical results have recently been reported. Havilah has commenced a ten hole percussion drilling program at the Maldorky project. This will allow a direct comparison of the potential of the Maldorky and Lilydale iron ore projects, and selection of the best targets for follow up diamond drilling for metallurgical samples.



Drilling so far has intersected magnetic siltstones of the Braemar Iron Formation where predicted from interpretation of aeromagnetic data. Sections and assay results will be reported in due course upon completion of the first round drilling program.
